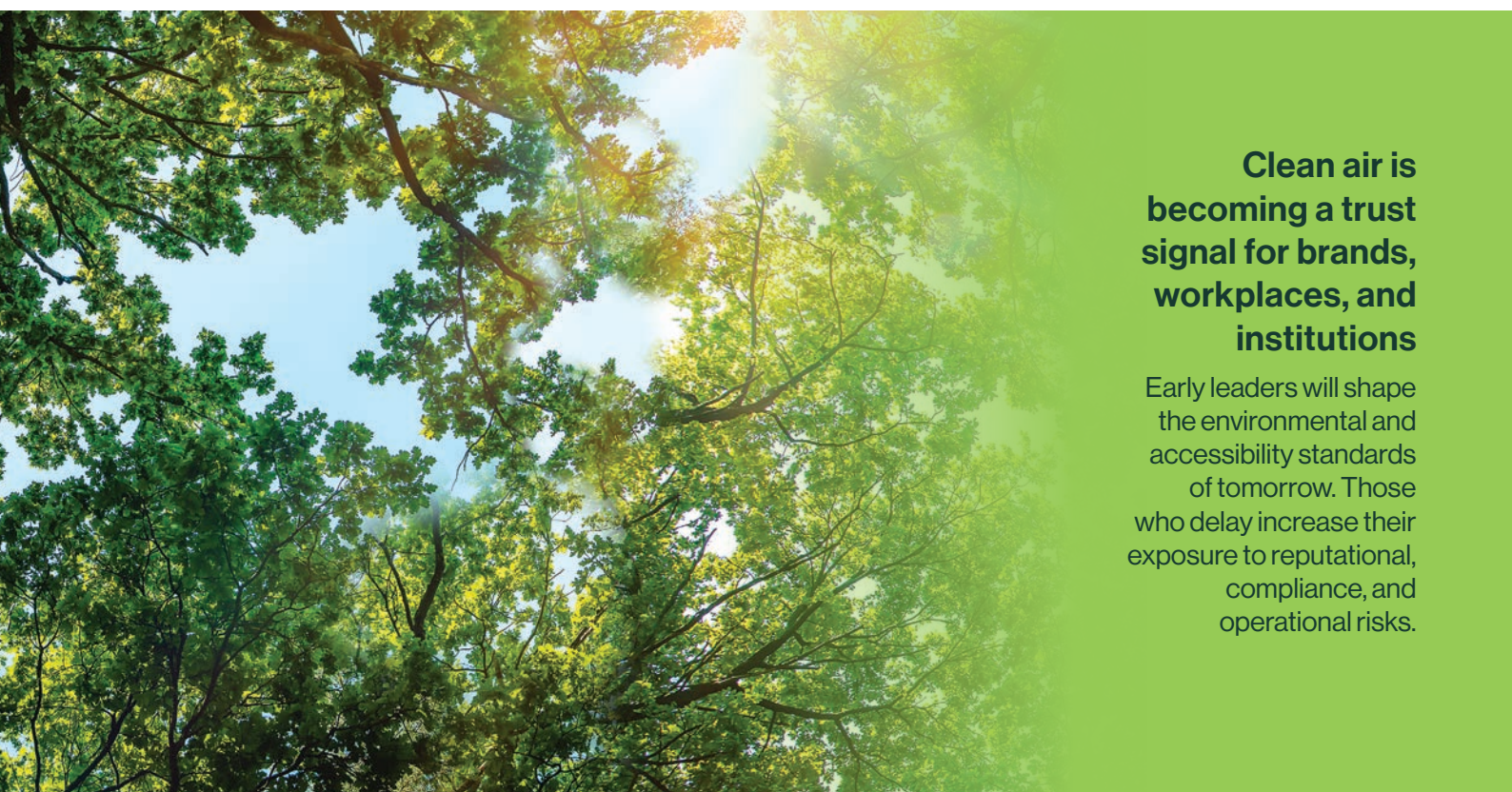

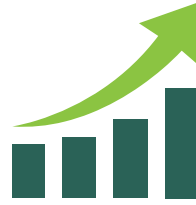

## What **MCS** Reveals About Indoor Environments

A lens on **environmental health, risk, and accessibility.**

**Multiple Chemical Sensitivity (MCS)** is a nationally and internationally recognized disability in which exposure to volatile organic compounds (VOCs) from fragrances, cleaning products, building materials, and other indoor air sources can trigger significant physiological reactions.

More than **one million** Canadians live with MCS, with women disproportionately affected.

For many, everyday environments create barriers to healthcare, housing, employment, education, and public participation.

Their experiences highlight a broader reality: when indoor spaces harm the most affected individuals, they also quietly impact many others.

Addressing MCS is not only about accommodation - it is about strengthening environmental health, risk management, and accessibility for everyone.

## Who We Are

Founded in 2022, EHAC-ASEC is a national Canadian charitable organization advancing accessibility, inclusion, and healthier environments for people affected by Multiple Chemical Sensitivity (MCS). We work in close partnership with the Environmental Health Association of Québec, bringing nearly 25 years of combined experience in environmental health, research, and disability inclusion.

Together, our organizations lead national efforts to improve indoor air quality, strengthen workplace and public-sector accessibility, and support evidence-based policy that benefits employees, consumers, and communities across Canada.

Our work is supported by government partners and a wide range of funders and is grounded in research and collaboration rather than advocacy alone.

## What We Do

Focused on real-world impact, our initiatives include:

- **Education and awareness on how to create and maintain healthy indoor environments**
- **National and international workshops and conferences that mobilize knowledge and build capacity**
